Set 13 external swellable casing packers for isolation of production string at the following depths: (1) 10,227' (2) 9885' (3) 9540' (4) 9194' (5) 8849' (6) 8508' (7) 8170' (8) 7814' (9) 7461' (10) 7113' (11) 6767' (12) 6421' (13) 6070'.
