WPX Energy requests authorization to flare this well due to an expected spike in nitrogen content above acceptable Beeline Gas Systems standards due to nearby frac activity on the NE CHACO.COM #181H, NE CHACO COM #182H, NE CHACO COM #183H. As a result, WPX Energy is anticipating that the NE CHACO COM #239H may experience crossflow. If a crossflow event on the well results in nitrogen content above Beeline Gas Systems standards, flaring may begin as soon as 10/30/14 given approval. The well would flare for up to 30 days. Pipeline quality gas should be obtained within 30 days. A gas sample will be collected upon the confirmation of crossflow and sent to a third party for a gas analysis. The results of the gas analysis will be submitted upon receipt.

The well flows to Beeline Gas Systems at a rate of 275 MCF/D.
