3. TIH w/ CIBP to 4200'. Test CIBP w/ packer.
4. Establish injection rate into PC perms w/ packer.
5. Squeeze off PC perms w/ CMNT. WOC.
6. Drill out CMNT, test squeeze to 600psi for 30 mins. If good test, drill out CIBP and clean out to PBTD.
7. TIH w/ 2 3/8" production TBNG and return well to Blanco Mesaverde production.
8. RDMO WSU.
