Pre-flushed w/ 5 bbls & circ. 30 bbls FW spacer, pumped 76 sx (122cf-21bbls=1.61 yld), Type I-II cement with 20% fly-ash. Dropped plug & displaced w/14 bbls FW. Cmt locked up. Tag plug @ 5' inside casing. Rig up to top out cement. Pumped 55 sx (88cf-15bbls=1.61 yld), Type I-II cement with 20% fly-ash through 1" tubing down backside of casing. RD cmt. WOC overnight.**  
**11/15/14 -DO cmt in sfc casing to 188'. RD RR @ 9:30 hrs on 11/15/14.**
