Hole diameter: 12.25", casing diameter: 9.625", casing weight and grade: 36ppf J55 LTC. Depth of 12.25" hole from 0-512'TVD/MD. Casing set from surface to 510' TVD/MD.

Pumped 207 sacks of Type III Halcem Cement + 2% bwoc CaCl + 0.125 lbs/sk Poly-E-Flake, yield 1.17 cuft/sk, mixed at 15.8 ppg on 10/16/14. Circulated 25bbbls to surface. WOC 6.5 hours for surface casing.

Float collar at 464'. TOC at surface and BOC at 507'.

Surface Casing pressure testing was performed on October 16, 2014 to 1500# for 30 minutes. Test was good. ✓
