Burlington requests permission to test the wellhead seal on the subject to satisfy the NMOC's letter dated 7/22/14 for a BH test failure. If the wellhead leaks, the wellhead will be replaced and the BH test will be redone to verify integrity. If the wellhead work fails to resolve the issue, then the BLM and OCD will be contacted and further remedial work will be initiated after approvals are received.
