2/2/15 - Halliburton cmt 4.5 liner w/ spacer / flush {10bbbls/H2O + 40bbbls/Chem spacer+ 10bbbls/H2O}, followed by Lead Cap @ 13# {7.7bbbls/30sx of Elastiseal system} followed by nitrogen foamed lead @ 13# {63.5bbbls/255sx of Elastiseal system}, followed by tail @ 13.5# {23bbbls/100sx of Expandacem system}, Displaced w/ 2% KCL 135.5/bbls. Landed plug @ 1668psi & bumped to 1808psi and HOLD. Floats held-1bbl back on Bleed off-Plugged down @ 2:45hrs. Dropped ball and set hanger @ 3649psi. Released from versaflex hanger setting casing liner. TOL @ 6193', {5770' TVD} to 11217', {5746' TVD}. Circ., out 19bbbls of cement back to surface w/ 2% KCL water. PSI tested versaflex hanger seals and 4.5 casing 1500'psi for 30 minutes, tested good and recorded on Chart. Rig down cement head and lines. Nipple down BOPE. Rig released @ 14:00hrs.
