Set P&A and Kick off plugs as follows:

Spot 1st P&A plug: 225sx (275 cf) of Class G w/ .3% R3, .1% FL-52A, (49 bbls of 15.4 ppg slurry) in a balance plug from 3,657' - 3,412', TOF at ~ 3668'. WOC for 6 hrs. Spot 2nd P&A plug: 225 sx (275 cf) of Class G w/ .3% R3, .1% FL-52A (49 bbls of 15.4 ppg slurry) in a balanced plug f 3,412' - 3,200'. WOC for 11.5 hrs. TIH and tag TOC at 3200'. Pump Kick Off plug: 675 sx (634.5 cf) of Premium Class G w/ .3% CFR-3, .14%HR5 (120.2 bbls of 17.2 ppg slurry) in a balanced plug f 3,200' - 2,500'. Pull up to 2400' & circulate while WOC for 7 hrs. TIH and tag TOC ~ 2500'. TOH and lay down 2-3/8" tbg stinger. TIH w/ 12-1/4" bit and dress off cement f 2458' to 2581'. TOH. PU directional tools and TIH. kick off cement plug at 2581'. Drill and slide f 2581' to 2670'. At 2670', 100% formation returns at 3.2 degree inclination. Continue drilling with control slides to 12-1/4" TD at 3795'.
