1/26/15 - Ran Pressur Tests = 200# Production Casing, 700# Intermediate Casing, & 650# Bradenhead. In 1992 we backed off the 4 1/2" casing - 2161' and performed a squeeze job on the 7" casing @ 660'. ConocoPhillips' plan forward to determine pressures issues is to Free Point & cut the 4 1/2" @ ~2161' (where the previous casing was backed off) and run CBL and Casing Integrity Log on the 7". We will re-visit the situation after we have the information from the logs.
