Mr. Mahan,

Dominions Production Corrected Action plan for the Hospah Sands #12/Main Line Release is approved with the following Conditions:

1. Dominion will test the open excavation side walls and base to confirm that no contamination above regulatory standards is left in place.
 - a. Soil will be tested for BTEX(EPA 8021B), Benzene (EPA 8021B), and TPH (GRO & DRO EPA 8015)
 - b. Site has been ranked a 20 and closure standards are set at 100ppm TPH, 50 ppm BTEX, 10 ppm Benzene.
2. Dominion will Notify District III OCD Office at a minimum 72 hours but no more than 1 week prior to soil sampling activities.
3. Dominion may remove contaminated soil to an approved Land Farm, or do on site remediation utilizing a shaker system
 - a. If Dominion chooses to do Onsite Remediation, within 30 days, after completion of excavation
 - i. Dominion will resample soil contamination after it has been through the Shaker.
 - ii. Providing Notification (Following same requirements as #2) to District III OCD Office.
 - iii. If Laboratory results return above Regulatory Standards, or if the soil has not been through the shaker system. Dominion will dispose of the contaminated soil at an approved land farm.
