Spudded well 1/25/2015. Drill 12-1/4" hole from 0 - 205' KB. Run in hole with 187' of 8-5/8" 24# J-55 ST&C csg. landed at 199' KB. Cmt with water spacer then 112 sx Type III cement w/2% CaCl & 1/4# flocele, cement to surface & return 6 bbls to close-loop pit. PT surf csg 700 psi for 30 min, all good. PT BOP & choke manifold (250# low; 2000# high).
