Run in hole with 22 jts 4-1/2" 11.6# J-55 ST&C csg (828.05'); landed @ 840.05' KB. Marker jt set @ 575.10' to 594.70' KB. On 1/22/2015, pump 10 bbls fresh wtr spacer, 10 bbls gel spacer, followed by 156 sx Type III + additives, 1.15 yield, 12.1 PPG. Start tail Class G + additives, 15.8 PPG, 1.45 yield 47 bbl slurry; 12 bbls good cement to surface. RDMODR 1/23/2015 @ 2:30 pm.
