13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. During removal of the below grade tank (BGT) soil underneath the tank was sampled. Analysis results showed TPH values of 760 ppm by Method 418.1 and 180 ppm by Method 8015B, indicating a release occurred at some time. Impacted soil under the BGT was excavated and removed until remaining soil samples resulted in TPH values of less than 100 ppm TPH, which is the cleanup standard for this site. Approximately 25 cubic yards of impacted soil were removed and transported to a landfarm for treatment. The excavated area was backfilled with clean soil and compacted. Attached are lab analyses, photos of the excavation, and a site map.
