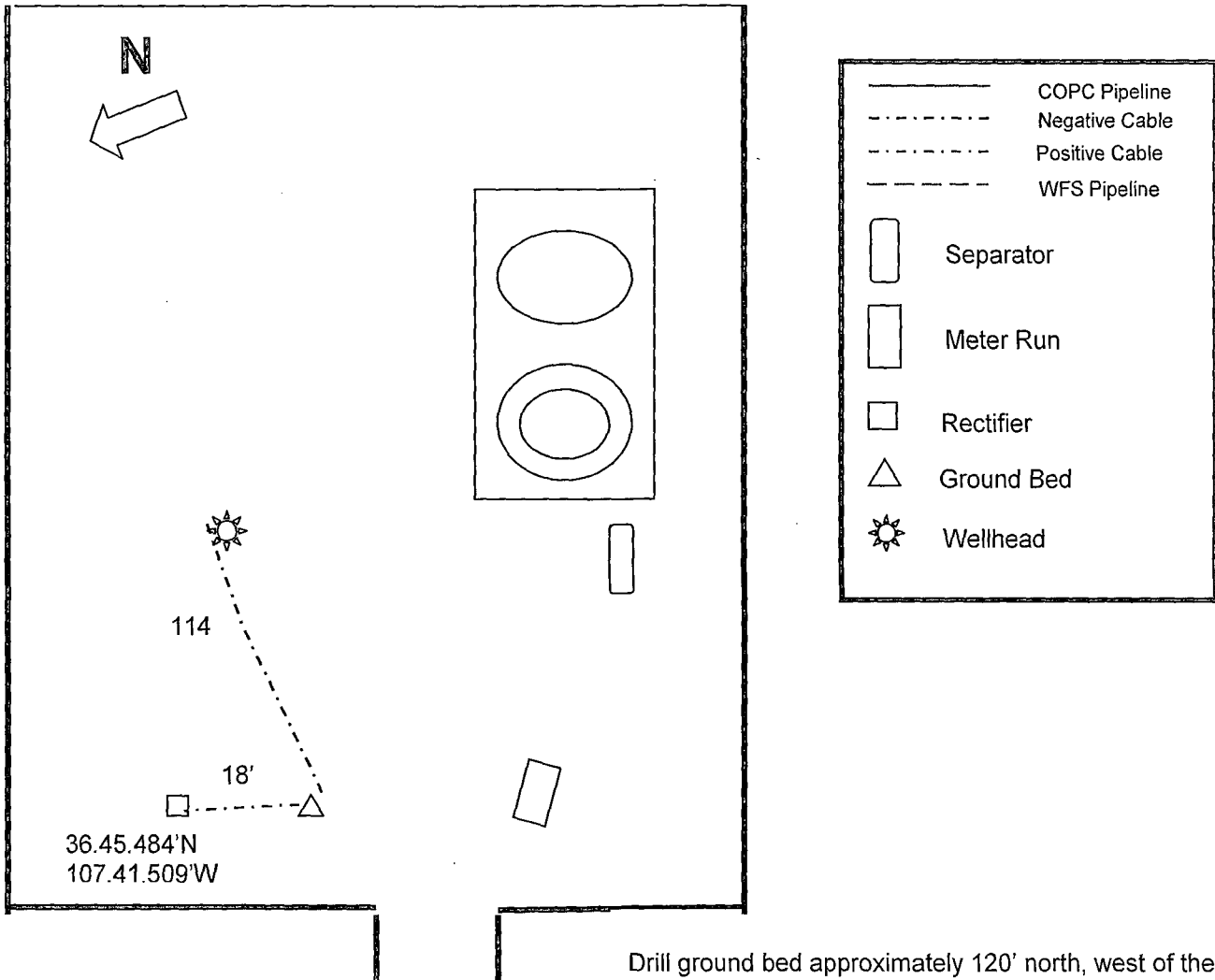

Section 5, T29N, R08W, N.M.P.M., San Juan County, NM



Drill ground bed approximately 120' north, west of the #1M well head at staked location. Install single well solar CP at staked location. Install cable to new ground bed and to the #1M wellheads at lengths below.

Sunray #1M: Cables

Negative: 114'

Positive: 18'

Total Ditch: 132'
