WPX Energy requests authorization to flare the **WARNER-CALDWELL #1A** due to a potential crossflow event as a result of nearby frac activity on CHACO 2308-04L #283H, CHACO 2308-04L #284H & CHACO 2308-04L #459H. If a crossflow event on the well results in nitrogen content above Williams pipeline standards, flaring may begin as soon as 4/20/15, given approval. The well would flare for up to 30 days. Pipeline quality gas should be obtained within 30 days. A gas sample will be collected upon the confirmation of crossflow and sent to a third party for a gas analysis. The results of the gas analysis will be submitted upon receipt.
