4/18/15- WPX Energy was running 7" casing and ran into a bridge and became stuck @ 4372'. The casing was cut off @ 4229', leaving 143' of the fish in the hole (consisting of FS & 3 1/2" jts of casing). Several fishing runs were made to attempt to free the fish. On one of the early runs, the grapple of the overshot was pulled out of the overshot making it unlikely for another overshot run to be successful. On the final run, the grapple on the spear was left in the casing or possibly on top of the casing, making it unlikely for another attempt to sting in the casing with the spear. This would also, be unlikely making any future runs.

WPX Energy notified & received verbal approval from BLM (Ray Espinoza) & NMOCD (Brandon Powell) to plug-back and sidetrack the curve section of the well. A 500', kick off plug will be set from the top off fish and the curve section of the well will be re-drilled.
