4/28/15 - Tested lines to 4600psi, started pumping @ 4bbls/min 10bbls FW, 40bbls Tuned spacer @ 10.5ppg YD 6.15, 41.1gal/sk, 5bbls FW, Lead 485sks (117.4bbls) mixed @ 13.3ppg, YD 1.36 cuft/sk, water 6.gal/sk, additive: 50% POZ, 0.3% Halad-D9, 0.05% SA1015, 0.7% Halad-413, 2.5# Kol-seal, pumped 10bbls/FW to pit to clear lines, Shut down Dropped Dart, displaced W/40bbls MMCR, 20bbls 2%KCL (inhibited) 30bbls fw, 42.4bbls 2% KCL. Total 132bbls. Bumped plug @ 2:50 4/28/15 to 2200psi, prior psi 1550, and bled back 1.75bbls floats held. Dropped 1.75 setting ball wait 30/min. Pressure up 4315psi, set liner. Pulled up to (165K) 50K over, slacked off to Neutral. Confirmed tool set. Rotated and release set tool. Circulated @ .5bbls/min pulled out of liner then raise rate to 6bbls/min. Roll hole w/ 180bbls KCL. After Tuned spacer shut annular and divert to blow tank. Circulated 17bbls of Good cement back to surface w/ annular shut. Pressure up to 1500psi and held for 30/min - Tested Good. Bled off psi. RD HES, LD cement head.
