E. This exception is requested for the following reasons: **1st Emergency Flare Extension**

WPX Energy requests authorization to flare the NE Chaco Com #292H due to a potential crossflow event as a result of nearby frac activity on **NE CHACO COM #209H, NE CHACO COM #210H, NE CHACO COM #243H, NE CHACO COM #244H, NE CHACO COM #271H**. If a crossflow event on the well results in nitrogen content above Williams pipeline standards, flaring may begin as soon as **6/15/15**, given approval. The well would flare for up to 30 days. Pipeline quality gas should be obtained within 30 days. A gas sample will be collected upon the confirmation of crossflow and sent to a third party for a gas analysis. The results of the gas analysis will be submitted upon receipt.
