
E. This exception is requested for the following reasons: **1st Emergency Flare**

WPX Energy requests authorization to flare the **NE Chaco Com #178H** if a potential cross flow event may occur as a result of a nearby Frac activity on the **NE Chaco Com # 254H, 255H, 264H, & 265H**. If a cross flow event on the well results in nitrogen content above Williams pipeline standards, flaring may begin as soon as **6/30/15 for 30 days**, given approval. A gas sample will be collected upon the confirmation of the cross flow and sent to a third party for results of the gas analysis. The gas analysis will submitted upon receipt.
