Elm Ridge Exploration Co LLC plugged and abandoned this well as follows: 4-24-15: Move in Rig up. 5-13-15: Move in Wireline Truck. Run CBL from 4750' to surface. 5-14-15: **PLUG #1**- Set Cement Retainer at 4686'. Set plug from 4782' - 4560'. Pumped 40 sks of Class G cement below and 15 sks on top. **PLUG #2**- Pumped 25 sks of cement and set plug from 3837' - 3627'. **5-15-15**: **PLUG #3**- Pumped 75 sks of cement from 1950'-1309'. **PLUG #4**- Pumped 64 sks from 1309'-856'. Trip in hole and tag cement at 856'. **5-16-15**: **PLUG #5**- Pump 15 sks from 856'-730'. **PLUG #6**- Ran in hole to 450' perforate 4 holes. Ran in hole to 275'. Perforate 4 holes. Pumped 105 sks from 507' to surface. Rig down. Cement to surface and out Bradenhead. All plugs were witnessed by Jose Ruybalid. The first 4 plugs witnessed by Leroy Lee with the Navajo Nation EPA. **ATTACHED: Cement Job Summary. CBL**
