The well has been shut-in since April, 2012 due to low gas prices and high water disposal costs. The last production was near 118 mcf/d and 79 bwpd. The well is capable of production but not economic production. We request continued shut-in and "ready to run" status with annual approval pending economic improvement in order to recover the remaining reserves. The location and well are monitored and managed to conserve the investment, the resources in the reservoir and on the surface.
