

Describe Cause of Problem and Remedial Action Taken.\*

The remedial action that is being taken is to dig out and haul off all impacted soil. When all contaminated soil is cleaned out, we will haul in clean dirt that is ok will the permission of where from the EPOC for the Tribe.

The affected area was inside the firewall of the production tank and all the condensate was contained. The action of cleanup will be to clean out all contaminated dirt and haul off to local approved land farm. And haul in new clean dirt, when all contaminated soil is taken care of. There will soil sampling as well as lab analysis done by Envirotech Laboratory.
