
E. This exception is requested for the following reasons: **1st Emergency Flare**

WPX Energy requests authorization to flare the **S. Chaco UT #340H** if a potential cross flow event may occur as a result of a nearby Frac activity on the **S. Chaco UT #342H & 346H**. If a cross flow event on the well results in nitrogen content above Enterprise pipeline standards, flaring may begin as soon as **8/12/15 for 30 days**, given approval. A gas sample will be collected upon the confirmation of the cross flow and sent to a third party for results of the gas analysis. The gas analysis will be submitted upon receipt.
