7/24/15- Halliburton cmt 4.5 liner w/ spacer/flush (10bbbls/H2O + 40bbbls/chem. Spacer) followed by primary cmt @ 13.3# (116.3bbbls/480sx of Extendacem system) Displaced w/ MMCR & 2% KCL 126bbbls. Landed plug @ 01:30PM on 7/24/15 @ 1189psi and hold. Floats held- 2.0bbbls back on bleed off. Circulate out 25bbbls of excess cement. Shut annular, tested liner T/1500psi for 30mins (held-ok). RD HES and Weatherford cmt head.

Run Tieback String: NU BOP; install antelope false bowl in WH. RU casers and run tie back string. Ran 125 jts of 4.5, P-110, 11.6# LT&C prod casing to 5707'(landed w/35,000). RU antelope tested truck and tested backside of casing. Tested to 1500psi for 30minutes-good. Chart held solid. L/D landing joint and Antelope tested equipment, Installed well cover & rig release @ 18:00. ✓
