### Reason/Background for Job

The Gage Com 001 is a Dakota well that was drilled and completed in 1967. The original stimulation on the Dakota has had limited success compared to offset wells, and the lower portion of it was plugged as a water shutoff in 1981.

It is proposed to perforate and hydraulically fracture the Dakota formation. Expected production rates are 200 MCFD and 13 BWPD.

#### **Basic Job Procedure**


- 1. Pull tubing
- 2. Drill out CIBP at 7188'
- 3. Clean out to PBTD of 7267'
- 4. Perforate the Dakota from 7047' 7260'
- 5. Fracture stimulate the Dakota
- 6. Unset packer(s) and pull tubing
- 7. Drill out composite plug(s)
- 8. Clean out to PBTD
- 9. Run tubing and production BHA
- 10. Run pump/rods
- 11. Return well to production
