WPX Energy requests authorization to flare the **CHACO 2408-32P #115H** if a potential cross flow event may occur as a result of a nearby Frac activity on the **MC 5 COM #112H, MC 5 COM #113H, MC 5 COM #119H & MC 5 COM #906H**. If a cross flow event on the well results in nitrogen content above Williams pipeline standards, flaring may begin as soon as **9/28/15 for 30 days**, given approval. A gas sample will be collected upon the confirmation of the cross flow and sent to a third party for results of the gas analysis. The gas analysis will be submitted upon receipt.
