


Owens 4-1/2", 11.6#/ft X-span patches (3.35" ID). Each patch will be 10' long. There will be 3 total patches to cover each set of squeeze holes. Once patches are in place WPX will perform a pressure test to ensure casing integrity prior to commencing completion operations.
