Drilled 12 1/4" hole to 323' on 5/18/05, set 14 jts of 9 5/8", H-40, ST&C, 32.3# casing at 318'. Cemented w/175 sx (37 bbls) "B" cement w/2% CaCl and 1/4# PSX Floseal. Circulated 13 bbls of cement to surface. Test casing to 1,500 psi.

Drilled 8 3/4" hole to 3,261' on 7/20/05, set 75 jts of 7", J-55 LT&C, 23# casing at 3,245'. Cemented lead w/550 sx (144 bbls) 50/50 POZ cement w/3% Gel, 5# Gilsontite, 1/4# Flocele, 0.1% CFR 3, 0.4% Halad 344 and tail w/75 sx (16 bbls) STD "B" cement w/0.4% Halad 344. Circulated 25 bbls of cement to surface. Tested casing to 1,500 psi.

Drilled 6 1/4" hole to 3,613' TVD on 7/21/05. Underreamed hole to 9 1/2" from 3,245' to 3,613'. Utilized natural and air assisted surges to remove near wellbore material. On 9/14/05 set 10 jts 5 1/2" 15.5, J-55 liner at 3,607' with liner top at 3,190'. Perforated liner with size 0.48" holes, total of 364 holes, 120° phasing, 4 SPF from 3,288' to 3,606'. Landed 2 3/8" production tubing at 3,590'.
