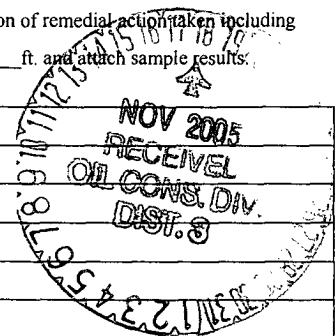

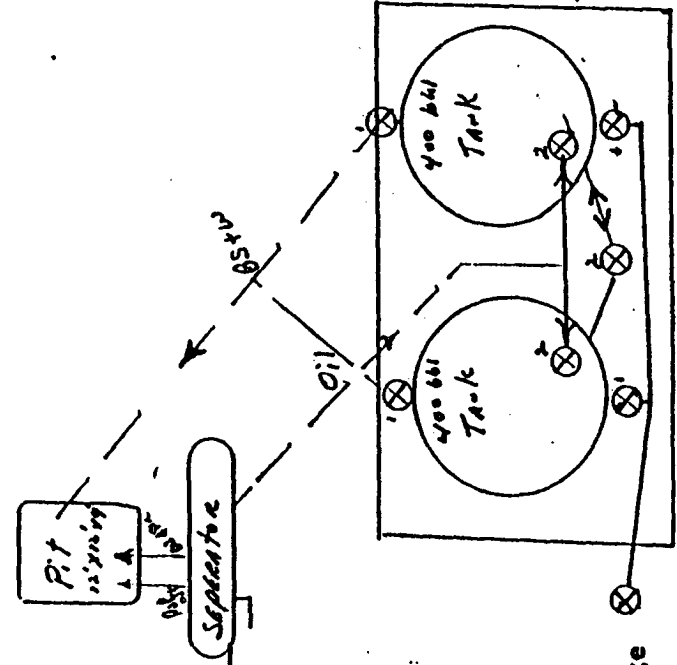
SITE SECURITY DIAGRAM
