A 1-1/2" tubing pump was installed in the Southland #3 well and the well was returned to production on October 29, 2005. Thompson Engineering requests a 90 day evaluation period to evaluate the economics of performing a similar work over on the Southland #1. If the Southland #3 continues to produce 15 MCFD or more after 90 days then a tubing pump will also be installed in the Southland #1. If the Southland #3 is uneconomic then a P&A procedure will be filed for both wells.
