Lance Oil & Gas Company, Inc., set a BP at 1,121' KB on October 9, 2005 to isolate the Middle Fruitland Coals (S-9). The Middle Fruitland Coals (S-9) were perforated from 1,048 - 1,059' KB, 1,081 - 1,083' KB and 1,093 - 1,095' KB with 4 SPF and fraced with 58,970 gallons Cross-Lined gel containing 146,400 lbs 16/30 Mesh Brady sand.

Operator will produce the Fruitland Coal (S-9) only for a short period of time to establish an initial production rate from the Middle Fruitland Coals (S-9). Operator will pull the bridge plug set at 1,100' KB and commingle the ~~Twin Mounds~~ Fruitland Sand Pictured Cliffs and Basin Fruitland Coal pursuant to the commingling order dated 04/03/2000 and the associated C-104's dated 06/09/2000 (Fruitland Coal) and 06/09/2000 (Pictured Cliffs).
