Test pipe rams & choke manifold to 250 psi low & 2000 psi high.

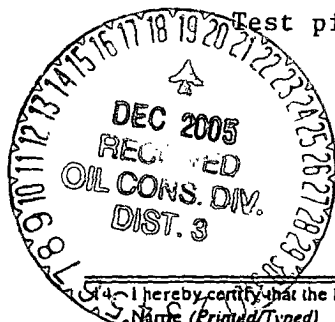
