09/08/05 Re-perforate Lower Fruitland Coal from 2420-31' with 44 holes - 0.43". Re-perforate Upper Fruitland Coal from 2307-09', 2343-45', 2356-58', 2360-68', 2371-81' with 96 holes - 0.43". Set 4-1/2" frac liner across Upper Fruitland Coal perforations. RU Stinger wellhead isolation tool.
09/09/05 Spearhead 1000 gals. 15% HCL. Refrac the Lower FRC from 2420-31' with 51,500 gals 70Q foam 20# linear gel, 5000# 40/70 sand and 45000# 20/40 sand at a maximum concentration of 3.85 ppg. RD wellhead isolation tool. Flow back frac.
09/10-12/05 Flow back well. Retrieve frac liner and TOH. Set 4-1/2" bridge plug @ 2400'. RU Stinger wellhead isolation tool.
09/13/05 Spearhead 2000 gals. 15% HCL. Refrac Upper FRC from 2307-81' with 86000 gals 70Q foam 20# linear gel, 10000# 40/70 sand and 72900# 20/40 brady sand at a maximum concentration of 4 ppg. RD wellhead isolation tool. Flow back frac.
09/14-19/05 Flow back frac and CO to BP @ 2400'. Drill out BP and clean out to PBTD @ 2638'.
09/19/05 Landed 2-3/8" tubing @ 2357'. Returned well to production.
