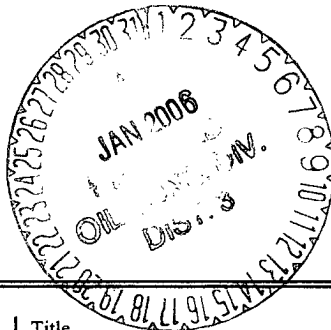

Elm Ridge Exploration Co, LLC spud this well on January 14, 2006. We drilled a 12 1/4" hole to 149'. We ran 8 5/8" 24 lb K-55 casing to 143'. We pumped 115 sks of STD cement w/ 2% CACL. Circulated cement to surface w/ 8 bbls excess. Pressure tested well to 1500 PSI.
