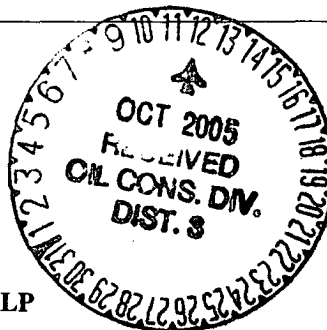

Ran pitot test. RIH w/5 1/2" 15.5# K-55 pre-perf'd liner and set @ 3684' w/TOL @.3347'(41' overlap into 7" shoe). Perfs @ (3438'-3523'; 3544'-3560'; 3569'-3617'; 3683'-3682') =102 holes. PU perf mill and milled out perf plugs. Circulate clean. RIH w/106jts 2 3/8" 4.7# J-55 tubing and set @ 3672' w/SN @ 3644'. RU to run rods. 9/23/05 RIH w/rods and pump. Spaced out. PT to 500#, ok. RD and released 9/27/05.
