Plans have changed from the original BOP design submitted with the APD. The current configuration from a 11" 3000# Double BOP with blinds on bottom & pipe rams on the top will be changed to an 11" 3000# single BOP with blind rams below an 11" Hydril Annual BOP, capable of closing on all pipe configurations COP is currently utilizing. The annular BOP will be tested to 1500 psi.
