13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. BMG requests permission to temporarily abandon this well for potential future use as an injection well, then to deepen the well. Provided permission is given, BMG will do the following (steps 1-2 with workover rig, step 3 with no rig, steps 4-6 with drilling rig)

- 1) Pull the tubing and go back in hole with packer.
- 2) Set packer at $\pm 2087'$ (end of $3\frac{1}{2}"$ casing @ $2137'$, open-hole completion $2137-2178'$).
- 3) Pressure test casing to at least 550# for thirty minutes.
- 4) Pull tubing and packer.
- 5) Deepen the well $\pm 87'$ (new TD $\pm 2265'$) to expose all of the Niobrara interval.
- 6) Rerun tubing and packer with packer set @ $\pm 2087'$.
