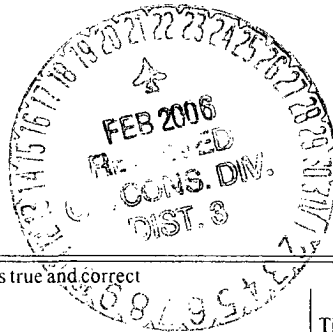

Devon Energy has completed the first Lewis zone from 5'174 to 5'394 on 11/19/05 with 26,670 gal 70Q N2 Linear Gel and 101,600# 20/40 Brady sand. The second Lewis zone is from 4,928' to 4,571' on 11/26/05 with 38,334 gal 70Q N2 Leaner Gel and 89,407# 20/40 Brady sand. These zones have been successfully added to the existing Mesaverde zone. The well was returned to sales on 12/01/05 with tubing end at 5,920'.
