Basin Minerals Operating Co. proposes to drill a vertical well at the above listed location and test the Fruitland Coal Formation. An 8-3/4" surface hole will be drilled to approx. 120' with spud mud. 7", 20# casing will be set and cemented to surface with 30 sx (36 cu.ft.) of CI "B" with 3% CaCl₂ and 1/4#/sk CF. A double ram, 2000 psi rated BOP will be installed and pressure tested to 600 psi. A 6-1/4" hole will be drilled using a fresh water - polymer mud system to approx. 2560'. 4-1/2", 10.5# casing will be set and cemented to surface with 200 sx (412 cu.ft.) of CI "B" cement with 2% SMS, 1/4 #/sk. celloflake and 5 #/sk gilsonite followed by 100 sx (118 cu.ft.) of CI "B" with 2% CaCl₂, 1/4 #/sk celloflake and 5 #/sk gilsonite. Open hole DIL and FDC/CNL/GR/SP logs will be run. Surveys will be run every 500'. The W/2 of Section 27 (320 acres) is dedicated to the Fruitland formation. Formation tops: Ojo Alamo - 1475', Kirtland - 1830', FT -2035', PC - 2360'.
