Production is proposed to be allocated based on a fixed rate percentage as follows: Basin Dakota= Gas 25%, Oil 25%, Water 25% and Blanco-Mesaverde= Gas 75%, Oil 75%, Water 75%. Please see the attached documentation supporting our allocation.
