

- 1) MOL RU. TOOH with 2-3/8" tubing.
- 2) PU and TIH with 4-1/2" retainer to 1000'. Squeeze below retainer with 18 sx cmt.
- 3) Sting out, mix and pump 85 sx, or sufficient volume, to bring cement to surface inside 4-1/2" casing.
- 4) Cut off well head 4 feet below surface and remediate location in accordance with regulatory agencies' conditions of approval.
