Notified Jicarilla BLM, BLM & NMOCD on 10/12/15

Plug and Abandonment Summary:

Plug #1 with 24 sxs (28.32 cf) Class B cement from 2149' to 1938' to cover the Nacimiento top.

Plug #2 with 53 sxs (62.54 cf) Class B cement from 386' to surface to cover the 8-5/8" casing shoe & surface, 1) pump 45 sxs to circulate good cement out 5-1/2" casing valve, 2) TOH & LD all tubing and plugging sub, RU pump to 5-1/2" casing valve, 3) pump 8 sxs to re-fill 5-1/2" casing.

Plug #3 with 16 sxs Class B cement top off casings and install P&A marker with coordinates N 36° 44' 42" / W 107° 11' 16".

Plugging Work Details:

10/13/15 MIRU A-Plus #14 rig. Open up well; no pressures. ND WH. NU BOP & function test. PU plugging sub & 2-3/8" workstring. TIH to 2149'. Roll hole w/ 52 bbls. Pressure test casing to 800 PSI, OK. Load bradenhead w/ < 1/8 bbl & pressure test bradenhead to 300 PSI, OK. Spot plug #1 with calculated TOC at 1938'. SI well. SDFD.

10/14/15 Travel to location. Open up well; no pressures. Function test BOP. Spot plug #2 with TOC at surface. ND BOP. NU WH. Dig out WH. Write Hot Work Permit. Cut off WH. Found cement at cutoff point in 5-1/2" and 8-5/8" casings. Spot plug #3 top off casings and install P&A marker with coordinates N 36° 44' 42" / W 107° 11' 16". RD & MOL.
