This sundry is a followup to the NOI dated 10/12/15 for notification of venting. It was necessary to vent this well due to stimulation operations on Energen's Chacon Jicarilla #602H. Energen vented the subject well intermittently from 10/10/15 to 10/20/15, and 10/22/15 to 10/28/15 (23 days in total) to relieve the wellhead pressure. An estimated volume of 1,357 mcf was vented. Venting operations ceased on 10/28/15 once the wellhead pressure returned to the normal operating pressure of approximately 200 psi and the well was retruned to production on 10/29/15.
