11/02/15: Spud well @ 8:00 hrs on 11/02/15. Drill 12.25" hole to 347'. Run 8 jts 9.625", 36#, J-55 LTC csg, set @ 337'. Cement with 190 sks (224 cf), VARICEM cmt, 2% CaCl₂, 1/8# per sk poly-e-flake. Check float (held). Circulate 18 bbls cmt to surface. Plug down at 13:13 hours on 11/07/15. WOC. Released rig 11/08/15.

Energen will pressure test the 9.625" casing once the drilling rig moves back onto location. An additional sundry will be turned in at that time.
