



WPX Energy requests authorization to flare the **NE Chaco Com #239H** if a potential cross flow event may occur as a result of a nearby Frac activity on **MC 6 Com 160H / 918H**. If a cross flow event on the well results in nitrogen content above Williams pipeline standards, flaring may begin as soon as **1/27/16 for 30 days**, given approval. A gas sample will be collected upon the confirmation of the cross flow and sent to a third party for results of the gas analysis. The gas analysis will submitted upon receipt.
