The prod casing has been successfully cemented in this well with full returns throughout the job and 52 bbls cement returns to surface.

As a result BP respectfully requests to change our logging plans for this well. Specifically, we plan to defer running a CBL until a decision is made to drill and complete the upper lateral in this well. If the upper lateral is not drilled, no CBL will be run.
