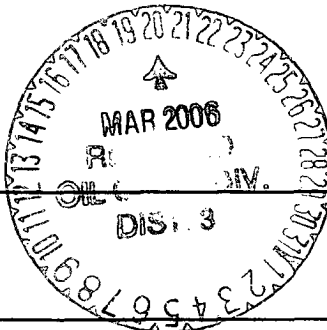

3/9/06 MIRU Mote #1. Spud 8-3/4" hole @ 0900 3/9/06. Drill ahead to 135'. Circulate hole. RIH w/4jts 7", 20#, J-55 ST&C csg & set @ 132'. Pumped preflush of 2bbbls H2O, then pumped 34sxs(54cu-10bbbls) Type 1-2 Portland cmt w/20% fly ash & 14.5 ppg into csg. Dropped plug and displaced w/3bbbls H2O. Circulate 2bbbls cmt to surface. WOC. Install wellhead. RD. MO PT csg will be shown on next report. PT will be conducted by the completion rig.

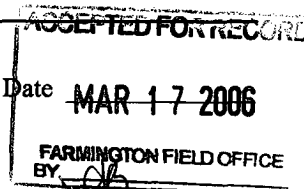
