Cemented w/175 sks 341 cu ft Halliburton Varicem cement w/6% bwoc bentonite, 5 lb/sk Kol-seal, 1/8 lb/sk Pol-E-Flake & 1% CaCl2 (12.4#/gal, 1.95 cu ft/sk). Tailed w/100 sks, 137 cu ft Halliburton HalCem cement blend w/1% bwoc bentonite, 5 lb/sk Kol-seal, 0.125 lb/sk Pol-E-Flake, 0.1% bwoc CFR3 and 2% CaCl2 (13.5#/gal, 1.37 cu ft/sk). Total slurry for the job 478 cu ft. Displaced w/33.5 bbls fresh water. Bump plug w/400 psi. Pressured up to 1000 psi. Float held ok. Circulated 30 bbls cement to surface. Job complete on 4/17/2016. D&D Rig #1 released 4/19/16. Pressure test will be reported on completion sundry. ✓
