Williams proposes to drill a vertical well w/ a 12-1/4" surface hole w/ water & benex to approx. 300' and set 9-5/8", 36#, K-55 casing, cement to surface w/ ~ 160 sx (211 cu.ft.) of Type III, w/ 2% CaCl<sub>2</sub> & 1/4# of CF. Will then drill a 8-3/4" hole to approx. 3221' w/ clear water & Benex. and set 7", 20#, K-55 casing, cement w/ 365 sx (759 cu.ft.) of Type III 65/35 w/ 8% gel, 1% CaCl<sub>2</sub> & 1/4#/# CF. Tail w/ 150 sx (209 cu.ft.) of Type III w/ 1% CaCl<sub>2</sub> 1/4#/# CF. Cement volumes calculated to circulate cement to surface. After 9-5/8" surface is set a 2M (double ram) blowout preventer will be installed & pressure tested to 1500 psi. A 2" kill line & 2" line to a choke manifold will also be installed.

A completion rig will then drill 6-1/4" hole to TD @ approx 3466' w/ air/mist. The well will then be open hole completed. A 5-1/2", 15.5#, K-55 liner will be ran over the open hole w/ 100' overlap into the intermediate casing. No cement. Will test the Basin Fruitland through perforated casing. If productive, the Fruitland will be produced thru 2-3/8" tbg.



