It is intended to recomplete the subject well in the Blanco Mesaverde (pool 72319) and then commingle it with the existing Basin Dakota (pool 71599). The production will be commingled according to Oil Conservation Division Order Number 11363. Allocation and methodology will be provided after the well is completed. Commingling will not reduce the value of the production. The State of New Mexico has been notified in writing of this application.

Proposed perforations are: MV - 3240' - 5688' ; DK - 7440' - 7711' These perforations are in TVD.

COPC will use some form of the subtraction method to establish an allocation for commingled wells.
